This serves two purposes to provide professional education living in the slums and secondly to remove the empathy and also to bridge the empathy gap is between the children living in the slums and "urban" girls.

#### 1. Project Details

#### 1.1 Objective of the project

- 1. Establishment of Urban Comprehensive Primary Eye Care Centers/Clinics and strengthening primary eye care services among underserved population of Delhi.
- 2. Screening for diabetic retinopathy among the diabetic patients in catchment population.
- 3. School vision screening for refractive errors and provision of spectacles for schools of catchment area.
- 4. Improved eye health seeking behavior of target communities by empowering them through behavioral change communication strategies.
- 5. Community based orientation training of primary health workers and local volunteers.
- 6. Provision of essential medicines for ocular diseases and provision of subsidized spectacles to the patients.

#### Comprehensive eye care services through Urban Comprehensive Primary Eye Care Centres/Clinics:

- The team from R.P.center will visit 3 locations of Delhi after need assessment by SSMI.
- This eye care team will serve a population of nearly 2 lakh.
- The key activities in the center will include screening and primary level treatment of patients with ocular morbidity, refraction services, referral of operable cases of cataract to R.P.Center for surgery, referral of cases with other ocular conditions and follow up of operated cases.
- Each team will visit three centers per week and around 40-50 patients are estimated to be registered in each center.
- Empowering and engaging communities through increasing awareness and active participation of local community at their doorstep.

Screening for specialist eye conditions e.g., Diabetic retinopathy, Glaucoma and Low Vision: The team will be train and well equipped with screening for specialist eye conditions like diabetic retinopathy screening, glaucoma case detection and low vision. Identified cases of DR, Glaucoma and Low vision will be referred at RP center for further investigations and management. Patients with functional low vision will be referred to RP center Low Vision Clinic for medical rehabilitation and their disability certification will be facilitated.

Activities to increase awareness regarding importance of regular eye examinations, availability of services and proper use of medication. The team from SSMI will conduct regular eye health education talks in the urban primary eye care center. IEC material will be developed and disseminated in the urban primary eye care center.

**Engagement of local community** people through training of volunteers for sustainable primary eye care model. People in the catchment area will also be oriented about primary eye care.

#### **Research Component**

Operational research for strengthening primary eye health care and capacity building. It will include following studies:

- A. Compliance study of use of glasses among VC attending patients.
- B. Uptake of subsidized spectacles vs free spectacles.

Computerized data records of all the patients seen in the center will be analyzed so that the epidemiological trends of ocular diseases and **outcome of cataract surgeries** will be assessed among the patients attending the Primary eye care clinic and referral services.

#### **Location and Beneficiaries**

Service delivery through this model- Three vision centers/locations will be identified in Delhi NCR area covering eye care needs of population of around 2 Lakhs population. The partner NGO - SSMI shall provide basic infrastructure for the vision centre/clinic thrice a week for RPcenter team. SSMI would provide support in community mobilization and IEC support for the eye health care awareness for common eye diseases in the community. SSMI would support in organization of clinic and referral of patients to RP Centre.

#### **Time Schedule**

The proposed Time period for completion of the project will be 3 years from the date of signing of MOA with implementing agency.

#### Monitoring and record maintenance

Monthly meeting will be held to review the performance and creating a new strategic plan, discuss the operational issues to run the center successfully. Faculty Community Ophthalmology will preside the monthly meeting. All issues and other information related to in patients care services will be discussed. Similarly Monthly meetings shall be conducted at SSMI with the Director SSMI for progress and future growth of the program.

Daily monitoring, monthly reporting and record keeping will be maintained. The electronic database like Electronic Medical Records (EMR) will be maintained at R.P. Center and SSMI. Performance report will be sent to funding agency on quarterly basis.

#### Anticipated Impact of the project

The major anticipated impact of the project will be that there will be nobody at risk of losing sight needlessly in the project area. Elimination of avoidable blindness, in turn will impact quality of life of people affected by eye health conditions in the sense that they will now be independent to pursue livelihoods of their choice and lead a dignified life.

Another major impact of the project will be a strengthened public health system from which the target communities will receive improved primary eye care services. The volunteers from community will be trained in primary eye care so that they may act as mobiliser for primary eye care services for the people in the community. They will be trained in identifying visually impaired patients in the community who will be referred to urban primary eye care centers for further management.
